Change Option #2 – For unlimited changes

Go back to the first page of the quote (Insured/Location Details) and review all entries. Once changes have been made (if needed), click the right arrow at the bottom of the page. If premium bearing changes were made, the premium amount on the screen should update automatically when the quote moves to the next page.



The next page in the quote will be the Coverages/Underwriting page. Any of these fields may be changed as well. Again, click the right arrow at the bottom when finished.
